A report released last month by the Center for American Progress concludes that corporate America has taken over the state courts. That's where 95% of all legal disputes are heard. The report says justice is influenced by massive campaign contributions to judicial candidates, with a majority of the contributions coming from corporations and their lobbyists.

For example, a 2011 report from the Brennan Center for Justice found that just three pro-business groups donated nearly 13 times as much as the entire labor movement during 2010 state judicial elections.

The recent study concluded that the rising amount of money spent in state elections has allowed companies to back prospective judges with pro-business records. This has, according to the report, created a pattern of rulings in favor of cutting costs at the expense of giving Americans a "fair trial".

In regards to general elections, it is apparent the U.S. Supreme Court will not overturn Citizens Untied v. Federal Election Commission the case in which the court ruled that corporations can spend without limits to support their candidates in elections. Therefore, people must overturn the decision. Public Citizen and its hundreds of thousands of supporters across the country are calling for a constitutional amendment to overturn the decision. The fight to preserve democracy is being spearheaded by Public Citizen.

BAD BOY BUGGY

For those of us who hunt have most likely heard of the Bad Boy Buggy, an electric 4x4 off road vehicle. What most of us have not heard, is that it is reported that the vehicle has serious design flaws. It is reported that the carts have electrical flaws causing it to surge and accelerate in a turn. DRYER VENT BLOCKAGE **CAN CAUSE A FIRE**

An estimated 2,900 clothes-dryer fires in residential buildings are reported to U.S. fire departments each year and cause rapid air loss. The tires made as an estimated \$35 million in property loses according to a new replacement tires for commercial report by the U.S. Fire Administration.

DRYER RECALLS

More that 20,000 gas dryers manufactured by LG Electronics and Sears' brand Kenmore Elite have been recalled because they could catch on fire due to a faulty gas valve. The valve may not shut off causing the dryer to continue to heat after the cycle is complete, posing a fire risk. There have been 141 complaints, ranging from burned clothes to minor burns to hands or arms.

If you own one of these dryers stop using it until it is repaired. Contact the manufacturer for repair or further information.
